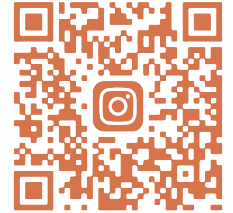

General Terms and Conditions

I. Acknowledgment and Acceptance of Terms

- Registration for IDEC2024 (hereinafter referred to as "the Event") signifies that you have read, understood, and agreed to all the contents of these General Terms and Conditions (hereinafter referred to as "Terms"). If you do not agree to any part of these Terms, please do not register for the Event.
- The organizer reserves the right to modify or update these Terms at any time without prior notice. Any changes to the Terms will be published on the official website of the Event. Your continued participation in the Event will be deemed as acceptance of the updated Terms.

II. Registration and Confirmation

- Participants must complete the registration process through the official website of the Event or designated channels and pay the corresponding event fees. Upon successful registration, participants will receive a confirmation email.
- Once registered, participants are bound by these Terms and cannot cancel or change their registration information without cause. If cancellation or changes are necessary, they must comply with the cancellation policy outlined in these Terms.

III. Cancellation Policy

- If participants need to cancel their registration due to unforeseen circumstances, they should notify the organizer as soon as possible and handle the refund according to the following regulations:
 - More than 30 days before the Event, 80% of the paid fees will be refunded.
 - Between 15 to 29 days before the Event, 50% of the paid fees will be refunded.
 - Within 14 days before the Event, no refund will be provided.
- In case of cancellation or postponement of the Event due to force majeure (such as natural disasters, epidemic outbreaks, etc.), the organizer will determine the refund policy based on the actual situation and promptly notify the participants.
- **[Refund Policy]** If cancellation is due to the reasons mentioned above, you may:
 - Choose another event date to participate.
 - Opt for a refund, but 10% of the registration fee will be deducted and any incurred administrative costs must be paid.

IV. Event Changes and Cancellation

- The organizer reserves the right to change the content, location, time of the Event, or cancel the Event due to force majeure or other special circumstances. In case of any changes or cancellations, the organizer will notify participants through the official website of the Event or other appropriate channels.
- If the Event is canceled, the organizer will refund the paid fees according to the cancellation policy. If changes to the Event prevent participants from attending, they may apply for a refund, and the specific refund policy will be determined based on the situation.

V. Event Rules and Code of Conduct

- Participants must comply with all the rules and codes of conduct at the Event venue, including but not limited to adhering to the schedule, respecting others, and maintaining environmental hygiene.
- The organizer reserves the right to take necessary actions against participants who violate the rules or behave inappropriately, including but not limited to warnings, requiring them to leave the Event, or prohibiting them from participating in future events.

VI. Wireless Internet Service

- Wireless internet service will be provided at the venue for participants to use during the Event. However, the quality of the internet connection may be affected by factors such as the venue environment and the number of users, and the organizer does not guarantee the stability and speed of the service.

VII. Catering Service

- Catering services, including breakfast, lunch, dinner, and snacks, will be provided during the Event. The catering will try to accommodate participants' dietary needs and preferences, but the organizer does not guarantee that all special dietary requirements can be met.
- If participants have special dietary needs or allergies, they should inform the organizer at the time of registration or in advance so that appropriate arrangements can be made.

VIII. Accommodation Arrangements

- If the Event includes accommodation services, the organizer will provide basic accommodation arrangements. Specific accommodation details, such as location, type, and conditions, will be provided in the Event confirmation notification.
- Participants should respect the regulations of the accommodation facilities and be responsible for their behavior. In case of any damages or violations, participants may be liable for the corresponding costs or responsibilities.

IX. Payment Methods

- Participants can pay the event fees through credit cards, bank transfers, or other methods. All payments should be completed within the specified time frame, and orders that are not paid on time will be considered invalid.

X. Order Confirmation

- After the payment is completed, participants will receive an order confirmation notification, which includes details of the Event, payment vouchers, and electronic tickets. Please keep these documents safe as they will serve as proof of participation in the Event.

XI. Visa Information

- International participants are responsible for obtaining their visas to Taiwan. The organizer can provide invitation letters or related documents to assist with visa applications, but does not guarantee the successful approval of visas.

XII. Health Declaration

- Participants should ensure that their health condition is suitable for participating in the Event. If there are any health issues or special medical needs, they should inform the organizer at the time of registration so that appropriate measures can be taken.

XIII. Personal Property Management

- All personal belongings should be kept safe during the Event. It is strictly prohibited to bring dangerous items or offensive weapons into the venue, and the use of any illegal drugs is also forbidden. Participants should comply with relevant laws and regulations and the rules of the Event venue.
- If participants violate this clause, the organizer reserves the right to confiscate the prohibited items, immediately require the participant to leave the Event venue, report to the police, and no fees will be refunded.

XIV. Parental Consent Clause for Minor Participants

- Participants under the age of 18 (hereinafter referred to as "minor participants") must provide a consent form signed by their parents or legal guardians at the time of registration, and ensure that their parents or legal guardians have fully understood and agreed to all the contents of these Terms.
- The organizer reserves the right to request minor participants to present the consent form and contact information of their parents or legal guardians, in order to contact them if necessary.
- Parents or legal guardians are responsible for the behavior and safety of the minor participants during the Event and must ensure that they comply with all the regulations and guidelines of the Event.

XV. Image Rights

- During the Event, the organizer or its authorized personnel will take photographs and record videos for Event documentation and promotion. Participants' participation in the Event is deemed as consent for the organizer to use their image rights.
- Purchasing tickets for this Event is considered consent for the organizer to use the images of participants taken during the Event for subsequent highlights reports, Event marketing, or exposure in social media. Regarding image rights, please refer to the following points:
 - The organizer strictly adheres to the use of images for official social media, online reports, and video highlights, not for other commercial purposes.
 - Participants agree that their images taken belong to the organizer and can be edited or explained as needed according to the above purposes.
 - Consent from participants has been sought in advance, and no further notification will be given after the fact.
- If participants do not wish their images to be used for Event promotion or other purposes, they should notify the organizer in writing at the time of Event check-in or in advance. The organizer will make every effort to respect participants' wishes and take appropriate measures to avoid using the relevant images.

XVI. Applicable Law and Dispute Resolution

- These Terms and the relationship between participants and the organizer are governed by the laws of the Republic of China (Taiwan). Any disputes arising from these Terms or the Event should be resolved through friendly negotiation between both parties. If negotiation fails, both parties agree to submit the dispute to the Taipei District Court in Taiwan for litigation.
